Notice of hearing was issued to the parties for today i. e. 23.04.2025.

2. The appellant is absent but has sent the written submissions, which are taken on record. However, the respondent filed the written submissions, relevant portion of which is as follows :

The RTI application is dated 03.05.2023 vide which the appellant sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority on 16.05.2023 and Second appeal has been received in the Commission on 06.07.2023 under Section 19 of the Right to Information Act, 2005. Notice of hearing was issued to the parties for today i. e. 23.04.2025.

2. The appellant is absent without intimation. However the respondent made the submission that the information sought can not supplied to the appellant as per section 24 (4) of the RTI Act, 2005 and requested to close the case. Section 24(4),provides that :

“(4) Nothing contained in this Act shall apply to such intelligence and security organisation being organisations established by the State Government, as that Government may, from time to time, by notification in the Official Gazette, specify:

Provided that the information pertaining to the allegations of corruption and human rights violations shall not be excluded under this sub-section:

Provided further that in the case of information sought for is in respect of allegations of violation of human rights, the information shall only be provided after the approval of the State Information Commission and, notwithstanding anything contained in section 7, such information shall be provided within forty-five days from the date of the receipt of request.”

ORDER

This order may be read with reference to the previous order dated 05.12.2024 and fixed for hearing on 10.04.2025, which was postponed due to public holiday declared by the Punjab Government on account of Mahavir Jayanti and fixed for today i.e. 23.04.2025.

2. The relevant portion of the order dated 05.12.2024 is as follows:

“2. None of the parties are present in today’s hearing. It is also a fact that the respondent had already submitted the reply in this case vide letter dated 26.09.2024 and the same was sent to the appellant. Further the appellant through an e-mail has requested to send the same at his e-mail, accordingly, the same was sent to the appellant to file the deficiencies, if any. Thereafter, the appellant sent an e-mail with the request to send the copy of the letter dated 26.09.2024 through an e-mail. According to the request of the appellant the same was sent to the appellant through e-mail mentioned in his RTI application.

*Thereafter, one another e-mail has been received from the appellant mentioning therein that his e-mail mentioned in the RTI application is defunct so he requested to resend the e-mail. On receipt of the said mail, again a copy the letter dated 26.09.2024 was sent to the appellant at an e-mail provided by the appellant. Today, an e-mail has been received from the appellant, mentioning therein that he has received the attachment on 03.12.2024 and he has to go through the details. Accordingly, an opportunity is granted to the appellant to file the deficiencies, if any, before the next date of hearing. It is also a fact that the appellant was directed to place on record a copy of letter no. 2023755392 dated 15.03.2023, information related to which has been sought by him but the appellant has not placed on record the said letter. One **last opportunity** is granted to the appellant to submit the same.*

3. Keeping in view the above, the case is adjourned. Also a copy of this order is being sent to the Principal Secretary Higher Education to deliver a copy of this order to the concerned PIO. It is also clarified that both the parties are directed to remain present on the next date of hearing, failing which the case will be decided ex-parte on merit. It is also clarified that no further adjournment will be allowed in this case."

3. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case as the appellant failed to represent this case/point out the deficiency. Hence, this case is **disposed of & closed**.
