ORDER(20th Hearing):

1. The RTI application dated 29.10.2021 pertains to information regarding **unauthorized colonies in Kharar City**, as specified by the appellant. The First Appeal was filed with the First Appellate Authority (FAA) on Nil, and the Second Appeal was filed before the Commission on 23.05.2022 under Section 19 of the Right to Information Act, 2005. The case was last heard on 29.01.2026.
2. This order may be read with reference to the Commission's previous order dated 29.01.2026, whereby the respondent PIO was directed to submit the requisite information along with proof, payment of compensation amount of Rs. 10,000/-, and to file an affidavit affirming the correctness and completeness of the information.
3. Today, none has appeared on behalf of the respondents. However, it is observed that the respondents have complied with the directions of the Commission to the extent that a copy of the information has been submitted and the compensation amount of Rs. 10,000/- has been paid through cheque, which has been handed over to the appellant, D R Singla, today in the Commission.
4. However, the respondent PIO has failed to file the affidavit as directed by the Commission in its previous order.
