3. The respondent PIO, represented by Shri Kamaldeep, JA, states that the complete information has already been provided to the appellant. Furthermore, the respondent proffered an oral explanation for the delay in addressing the RTI application, in view of which, I am satisfied that there was no malafide intent on the part of the PIO to deny or delay the sought information.

4. After considering the above facts it noted that the RTI application has been adequately addressed. Moreover, the Commission issue a warning to the PIO to handle RTI applications promptly and to avoid delays in the future.
