2. The respondent PIO, represented by Shri Gaurav Kumar, JE, states that a reply has already been sent to the appellant vide letter dated 24.10.2025. Further, he states that the information sought by the appellant is not specific.

3. The appellant is absent without intimation. It is also a fact that notice of hearing was sent to him through registered post but even though he is absent, which seems his absence is intentional and willful. The appellant has not submitted any written submission and nor has he opted to be present at today's hearing. The *prima facie* appears that the appellant does not intend to pursue the case and he has nothing to say in this regard.

4. The Commission has examined the RTI application and concurs with the respondent PIO that the requested record is not specific. The appellant is advised to make his request for information under the RTI Act, 2005, more specific as the present RTI application appears to be more in the way of fishing enquiry.

5. The appeal is accordingly **disposed of and closed**. Copy of the order be sent to the parties.
