ORDER:

1. This order may be read with reference to the previous order dated 02.07.2025 passed by the Commission.
2. The appellant's is again absent at today's hearing without intimation and has consistently failed to appear in any of the earlier hearings scheduled before this Bench. Despite repeated notices and orders issued by the Commission, no communication, explanation, or representation has been received from the appellant. The continues absence of the appellant, leads to an unproductive expenditure of official time and effort of PSIC as well as the Public Authority, which adversely affects the discharge of their regular duties in their respective departments.
3. The respondent PIO files a reply sent to the appellant vide letter dated 29.07.2025. The relevant portion of the same is reproduced as under:-

4. After examining the case file, it is revealed that the respondent has supplied the givable information to the appellant and copy of the same submitted today in the Commission. The appellant has not attended the Commission consequently 2nd time entailing thereby that he does not want to follow up his case further. As the appellant is absent and nothing has been heard from him regarding the receipt of the information. It is presumed that he is satisfied with the information provided and has nothing to say.

5. The Commission, has to adjudicate as per provisions mandated by RTI Act, 2005. This is a case of grievance of the appellant who has attempted to find redressal thereof by filling second appeal in the Commission. The perception of the appellant that use of RTI Act can be employed as a mechanism for redressal of his grievance is beyond the paradigm of the Act. The Commission advises the appellant to approach the competent forum or Court for redressal of his grievance as it is unable to go outside the jurisdiction stipulated by the RTI Act.

6. Keeping in view of the above, the Commission is of the view that no further intervention is warranted in these cases. Hence, both cases are **disposed of and closed.** Copies of the order be sent to the parties.
