The Commission observed that there is complete negligence and laxity in the public authority in dealing with the RTI application.

4. The Commission takes a very serious view of the respondent PIO's conduct in ignoring this RTI application and deems it fit to serve the respondent PIO, office of, Secretary, Regional Transport Authority, Amritsar, with this Show Cause Notice.

5. The respondent **PIO, office of, Secretary, Regional Transport Authority, Amritsar**, is herewith ordered to **SHOW CAUSE** as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **24.02.2023**. If there is / are other PIO / PIOs responsible for the delay in providing the information, the incumbent PIO is directed to inform such PIO(s) of the Show Cause and direct them to appear before the Commission along with written replies.

“In addition to the written reply, the respondent PIO is also given an opportunity under Section 20 (1) provision there to, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him *ex parte*.”

6. The PIO, office of, Secretary, Regional Transport Authority, Amritsar, is directed to supply the requested information to the appellant through registered post within 15 days after receipt of this order, under intimation to the Commission. The respondent PIO, office of, Secretary, Regional Transport Authority, Amritsar, is further directed to attend the next hearing in person with a written reply to the Show Cause Notice. Failure to comply and attend the hearing, will compel the Commission to secure his presence through service of **Bailable Warrant**.
