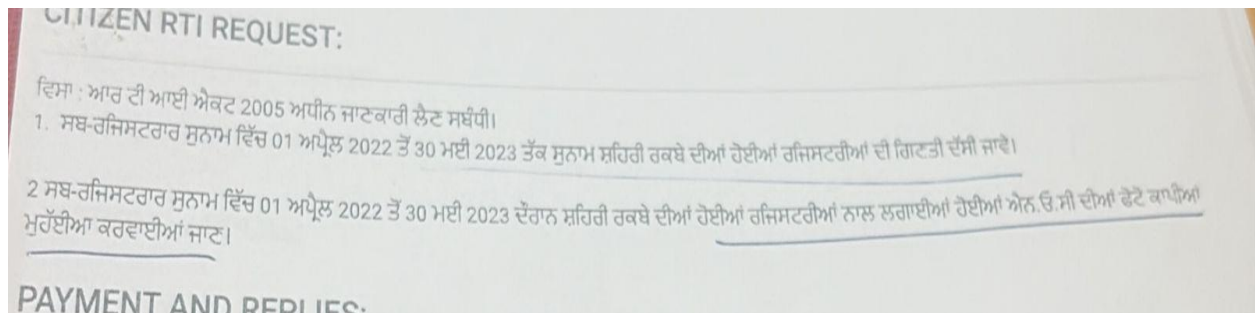

ORDER

1. The RTI application is dated 07.06.2023 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 31.07.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 28.10.2023 in the Commission.
3. Today neither the appellant nor the respondent is present. They have even not informed the Commission about their absence for today's hearing. After examining the RTI filed by the appellant, it is ascertained that the appellant demanded following information:-



After going through this case very minutely , it is observed that the information demanded by the appellant cannot provided to him under Section 8 of the RTI Act 2005.

4. The appellant may take note that the Commission relied upon the decision dated 13.11.2019 of Hon'ble Supreme Court of India in Civil Appeal No. 10044 of 2010 titled in Central Public Information Officer, Supreme Court of India Vs. Subhash Chandra Aggarwal, regarding Right to Information Act, 2005 in which in para no. 59 of the above referred case had defined 'Personal Information' under the Right to Information Act 2005, the relevant part of the judgment is reproduced below:-

"Reading of the aforesaid judicial precedents, in our opinion , would indicate that personal records, including name, address , Physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as personal information. Similarly, professional records, including qualification , performance , evaluation reports, ACRs, disciplinary proceedings, etc. Are all personal information. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded. Including that of the family members, information, relating to assets, liabilities, Income tax returns, details of the investments, lending and borrowing etc. are personal information. Such personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interest is satisfied. This list is indicative and not exhaustive.

Hence, the appellant seeks personal information which cannot be provided to him as per above said law/directions of the Hon'ble Supreme Court of India. Therefore the present appeal filed by the applicant stands disposed of and closed. Copy of the order be sent to the parties.
