This Order may be read with reference to the previous order dated 09.12.2025 passed by the Commission.

2. At today's hearing, the appellant submits that inspite of the directions of the Commission, partial information has been provided to him. The appellant further pointed out that the information pertaining to point nos. 2, 4 & 6 is still pending.

3. The respondent PIO states that point wise complete information as per official records has been provided to the appellant. The respondent PIO further adds that they have brought the original record for the perusal of the appellant. The appellant requests the Bench to direct the respondents to allow him to inspect the record.

4. Post deliberations, the Bench directs the respondent and the appellant to sit together in the adjacent Court room, where the respondent will explain the appellant position on each point and then to report back to the Bench.

5. Post meeting, the respondent states that the information on point nos. 2 and 4 has been provided to the appellant but there is no FIR copy, in the official records, as demanded by the appellant. They also add that all details related to this case are being dealt with by them only and nothing is left to be provided to the appellant.

6. The perusal of the file indicates that the respondent PIO has been making efforts to provide information. However, due to certain systemic deficiencies in the office of the public authority concerned,

there has been delay in serving the request. Due to this, the appellant has had to suffer harassment in getting the information. In the facts and circumstances of the case, I am of the view that ends of justice will be met by directing the respondent PIO to file an affidavit on non-judicial stamp paper, within 15 days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in official records has been supplied to the appellant in AC: 4085/2024. It is further stated that nothing has been concealed therein and the supplied information is factually true and correct. The original affidavit be sent to the appellant, before the next date of hearing, under intimation to the Commission.

7. The Commission has to adjudicate as per provisions mandated by RTI Act, 2005. This is a case of grievance of the appellant who has attempted to find redressal thereof by filling second appeal in the Commission. The perception of the appellant that use of RTI Act can be employed as a mechanism for redressal of his grievance is beyond the paradigm of the Act. The Commission advises the appellant to approach the competent forum or Court for redressal of his grievance as it is unable to go outside the jurisdiction stipulated by the RTI Act.

8. With the aforesaid directions, the instant appeal case and hence the appeal is **disposed of and closed**. Copies of the order be sent to the parties.

(We hold that under Section 6(3) of the Act ibid the legal obligation of a PIO who receives a request for information under Section 6(1) of the Act is limited to transfer this request to only one public authority that holds the information. This obligation does not extend to transfer the request to multiple public authorities.)
