5. In the aforementioned circumstance, it is, thus apparent from the response of

the PIO that there has been delay in providing the information. There are systemic

deficiencies in the manner of receiving and disposing of applications. The department still

does not appear to be properly tuned to the performance of its obligations enshrined under

the RTI Act. The departmental officials are not properly sensitized and trained to discharge

their functions under the RTI Act 2005.

6. The Commission, therefore, of the view that the Appellant deserves to be awarded

compensation under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered

by him on account of delayed supply of information. Hence the Commission is of the view

that ends of justice would be met by awarding a sum of Rs. 3000/- (Rupees three

Thousand only) by way of compensation to the Appellant. This amount shall be payable by

State Exchequer within fifteen days.

7. The perusal of the case file shows that despite repeated directions, the Respondent-

PIO is not appearing before the Commission. Hence, bailable warrant be issued to Public
