APPEAL CASE NO. 1739 OF 2025

is directed to supply the requested information sought at point nos. 2 to 5 of the RTI application, to the appellant through registered post within 15 days after receipt of this order, under intimation to the Commission, failing which punitive and stringent provisions of the RTI Act, 2005 could be invoked against him. The respondent PIO O/o Department of Governance Reforms, Punjab, Chandigarh, is exempted from further hearings of this appeal case.

- 5. Both parties are directed to appear before the Commission on the next date of hearing for deliberations. It is also clarified that in case of defiance of this order, the case will be decided on merit, ex-parte.
