ORDER

This order may be read with reference to the previous order dated 25.06.2025 vide which all the points relating to the RTI of the appellant was discussed between both the parties. Accordingly the respondent was directed to file point wise reply.

2. Today the appellant states that he is not satisfied with the information provided by the respondent. He further states that he has not been provided the reply within the time as prescribed under the RTI Act 2005. He has, therefore, suffered mental harassment and financial loss in attending the hearings in the Commission. For this the appellant demands that the Respondent be penalized

3. Respondent states that the point wise reply has been sent to the appellant as well as to the Commission.

4. The perusal of the RTI shows that the appellant demanded information in question form. The appellant may note that it is settled legal position that information that can be provided under the RTI Act is that which is already on record of the Public Authority. The PIO cannot be asked to create any record for answering the RTI questions. As per the Supreme Court decision in **Khanapuram Gandaiah vs Administrative Officer & Ors on 4 January, 2010 in SPECIAL LEAVE PETITION (CIVIL) NO.34868 OF 2009** the definition of information as given under Section 2(f) of the RTI Act 2005, shows that an applicant under Section 6 of the RTI Act can get any information which is already in existence and

accessible to the public authority under law. Of course, under the RTI Act an applicant is entitled to get copy of the opinions, advices, circulars, orders, etc., but he cannot ask for any information as to why such opinions, advices, circulars, orders, etc. have been passed.

Still, the respondent has given him reply. After going through the reply, it has been ascertained that the Respondent has provided appropriate and permissible reply to the Appellant. Further, it has also been ascertained that this is a case of grievance of the appellant who has attempted to find redressal thereof by filling second appeal in the commission. The perception of the appellant that use of RTI Act can be employed as a mechanism for redressal of his grievance is beyond the paradigm of the Act. The Commission advises the appellant to approach the competent forum or court for redressal of his grievance as it is unable to go outside the jurisdiction stipulated by the RTI Act.

6. The perusal of documents available on the case files, it is observed that the reply/information has been sent to the appellant but not within stipulated period as prescribed under the RTI Act 2005. For this the respondent tenders unconditional apology regarding delay occurred in this case and made oral submissions in this regard, which reveals that the delay was not deliberate. Therefore this is not a fit case for imposition of penalty.

7. It has also been noted that Hon'ble Delhi High Court in W.P.(C) 11271/2009 Registrar of Companies & Ors v. Dharmendra Kumar Garg & Anr. (delivered on: 01.06.2012) has held as under:

" 61. Even if it were to be assumed for the sake of argument, that the view taken by the learned Central Information Commissioner in the impugned order was correct, and that the PIOs were obliged to provide the information, which was otherwise retrievable by the querist by resort to Section 610 of the Companies Act, it could not be said that the information had been withheld malafide or deliberately without any reasonable cause. It can happen that the PIO may genuinely and bonafidely entertain the belief and hold the view that the information sought by the querist cannot be provided for one or the other reasons. Merely because the CIC eventually finds that the view taken by the PIO was not correct, it cannot automatically lead to issuance of a showcase notice under Section 20 of the RTI Act and the imposition of penalty. The legislature

has cautiously provided that only in cases of malafides or unreasonable conduct, i.e., where the PIO, without reasonable cause refuses to receive the application, or provide the information, or knowingly gives incorrect, incomplete or misleading information or destroys the information, that the personal penalty on the PIO can be imposed. This was certainly not one such case. If the CIC starts imposing penalty on the PIOs in every other case, without any justification, it would instill a sense of constant apprehension in those functioning as PIOs in the public authorities, and would put undue pressure on them. They would not be able to fulfill their statutory duties under the RTI Act with an independent mind and with objectivity. Such consequences would not auger well for the future development and growth of the regime that the RTI Act seeks to bring in, and may lead to skewed and imbalanced decisions by the PIOs Appellate Authorities and the CIC. It may even lead to unreasonable and absurd orders and bring the institutions created by the RTI Act in disrepute."

8 Keeping in view the facts of the case and the submissions made by both the parties, no further intervention of the Commission is warranted in the matter and this Appeal stands **disposed and closed** accordingly. Copy of the order be sent to the parties.

75% of their time in collecting and furnishing information to applicants under the RTI Act. It has further been observed by the Apex Court that Act should not lead to employees of public authorities prioritizing 'information furnishing' at the cost of their normal and regular duties. 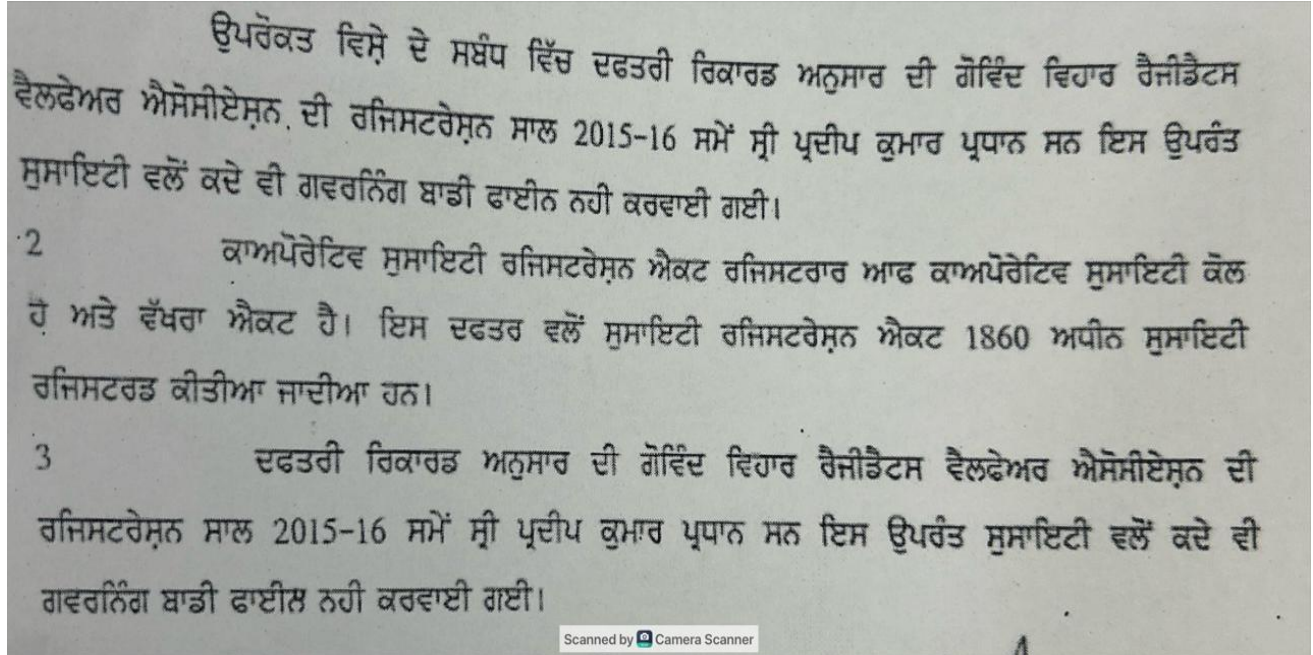
