5. Therefore, the Commission deem it appropriate to issue show cause notice under section 20 (1) of the RTI Act , 2005, to the respondent-PIO as to why penalty be not imposed upon him for willful delay / denial in providing the information/reply to the RTI

applicant. He is directed to file reply to the show cause notice in writing before the next date of hearing.
