3. **Respondent's BDPO Written Submissions:** The Commission has perused the communication of the Block Development and Panchayat Officer (BDPO) vide letter **No. 2039 dated 29.09.2025**, which records as follows:

- The initial RTI application was transferred under **Section 6(3)** to the PIO-cum-Panchayat Secretary, Shri Kiranpal Singh. - **Shri Amit Kumar**, the newly posted Panchayat Secretary-cum-PIO of Gram Panchayat Malakpur Bet, was directed vide **BDPO letter No. 2015 dated 26.09.2025** to appear before the Commission. Shri Amit Kumar, however, has intimated that **no record has been handed over to him by his predecessor.**
- The BDPO has further written to **Shri Kiranpal Singh** vide **letter No. 2020 dated 26.09.2025** to hand over the complete Gram Panchayat Malakpur record to his successor.

ORDER

1. This order may be read with reference to the previous order dated **28.05.2025**, whereby both parties were directed to mutually fix a date within fifteen (15) days for inspection of the relevant records, and the PIO was instructed to provide certified copies of any remaining information identified during inspection.

2. The appellant later informed the Commission (email dated **18.06.2025**) that no inspection was conducted despite his visit on **12.06.2025**. During last hearing dated **03.07.2025**, **Sh. Om Parkash, V.D.O.**, stated that he was unaware of the visit and had since been transferred after handing over charge. Observing non-compliance, the Commission had issued a **Show Cause Notice** to the concerned PIO and directed the present V.D.O. to appear with records on the next date.

3. **Today, only the appellant is present.** He has submitted that **no compliance whatsoever** has been made by the respondent PIO or by the office of BDPO Fatehgarh Churian in spite of repeated directions of the Commission. No inspection was facilitated, and no certified information has been provided to date.

4. In view of the persistent **non-compliance**, the **disregard of Commission's directions**, and the **harassment and detriment** caused to the appellant in pursuing his right to information, the Commission deems it appropriate to award a **compensation of Rs. 3,000 (Rupees Three Thousand only)** to the appellant. The amount shall be paid by the **Public Authority**, i.e., O/o BDPO Fatehgarh Churian, District Gurdaspur, within **15 days** of receipt of this order.

5. **Failure to comply** with this direction shall invite **penal proceedings under Section 20(1) of the RTI Act, 2005**, and the Commission may also consider initiating further action for enforcement of compliance.

ORDER

This order may be read with reference to the previous order dated **03.07.2025**, wherein the Commission had noted that despite directions issued on **28.05.2025**, the inspection of the relevant Panchayat records had not been facilitated and a **Show Cause Notice** was issued to the concerned PIO, O/o BDPO Fatehgarh Churian, for failure to comply with the Commission's order and for obstructing access to information. The present V.D.O. was also directed to appear with complete records and an explanation for non-compliance.

2. **Today, only the appellant is present.** He has submitted that **no compliance whatsoever** has been made by the respondent PIO or the office of BDPO, Fatehgarh Churian, despite repeated directions of the Commission. No inspection has been facilitated, nor have certified copies of the Panchayat records been supplied to date.
3. In view of the persistent **non-compliance**, the **disregard of Commission's orders**, and the **harassment and detriment** caused to the appellant in pursuing his right to information, the Commission deems it appropriate to award a **compensation of Rs. 3,000 /- (Rupees Three Thousand only)** to the appellant. The amount shall be paid by the **Public Authority**, i.e., O/o BDPO Fatehgarh Churian, District Gurdaspur, within **15 days** of receipt of this order.
4. **Failure to comply** with these directions shall invite **penal proceedings under Section 20(1) of the RTI Act, 2005**, and the Commission may also initiate further action to secure enforcement of compliance.
5. A **copy of this order** be sent to the **Director, Rural Development and Panchayats, Punjab**, for ensuring compliance of the above directions and reporting the status to the Commission.
