2. Both the parties are absent without any intimation to the Commission for today's hearing.
3. After examining the case file, it is found that appellant was also absent on the previous hearing held on 27.11.2018 and requested for an adjournment through telephonic message. Another opportunity was given to the appellant to represent this case in person or through any of his representative(s) on the next date of hearing positively and matter was adjourned for further hearing on 31.12.2018 i.e. today but the appellant failed to do so.
4. Last opportunity is given to the appellant to represent this case in person or through any of his representative(s) on the next date of hearing positively, failing to which case will be decided on the available evidences.
5. Matter is adjourned for further hearing on **30.01.2019 at 11:30 A.M.**
6. Announced in the Court, copy of the order to be sent to the parties through **registered post.**
