ORDER

The appellant further states that the respondent Public Information Officer has not supplied the information pertaining to point no. 5 and 6 of his RTI application regarding the gym fee/ membership fee charged from the students/gym members. The appellant states that he has documentary evidences pertaining to point no. 5 and 6 but the respondent Public Information Officer is not supplying the information. He has requested the Commission to direct the respondent to supply the same.

3. The respondent Public Information Officer reiterated that she has supplied the information on the basis of record, and in case the appellant has any

2. The respondent Public Information Officer has sent a letter no. 2431 dated 29.11.2021 which is already in the case file. The representative of the respondents states that the information has already been provided to the appellant except pertaining to the year 2012 as the diary register pertaining to the year 2012 could not be traced in spite of the best efforts made by him. He also states that the same was not handed over to the present custodian of the record.

3. The Commission observes that misplacement of diary register pertaining to the year 2012 is a serious lapse, therefore, the S.D.M. Jagraon is directed to initiate an inquiry and fix responsibility of erring officials. Also the respondent-Public Information Officer is directed to file the reply in this regard before the next date of hearing to take the matter to its logical end. With these directions the case is adjourned.
