ORDER:

1. This order may be read with reference to the Commission's previous order dated **10.06.2026**, whereby, inter alia, the respondent was directed to ensure compliance of the Commission's earlier directions regarding furnishing the **FIR/DDR or action taken report concerning the missing record** and payment of **₹5,000/- compensation** to the appellant.
2. The matter is taken up for compliance hearing today. Both parties are present and heard.
3. The appellant, **Sh. Dinesh Lamba**, is present along with **Dr. Jagjit Singh Cheema**.
4. On behalf of the respondent, **Sh. Ajay Kumar, Building Inspector**, appeared and submitted that, in compliance with the directions of the Commission regarding lodging of FIR/DDR, a letter bearing **No. 1424 dated 24.10.2025** was sent to the **Commissioner of Police, Jalandhar**, followed by reminder **No. 1669 dated 14.09.2026**, requesting registration of FIR/DDR. However, no response has been received from the Commissioner of Police, Jalandhar so far. Regarding the compensation of **₹5,000/-**, he requested some further time for compliance.
5. The Commission has considered the submissions and perused the record. It is observed that despite issuance of the aforesaid communications by the respondent public authority, the required **FIR/DDR or action taken report has not yet been placed before the Commission**, nor has complete compliance been demonstrated. The matter also pertains to compliance of the compensation awarded under **Section 19(8)(b) of the RTI Act, 2005**.
6. In the interest of justice, the respondent is granted a **last opportunity** to ensure complete compliance. The respondent PIO shall **submit proof of payment of ₹5,000/- compensation to the appellant** and shall also place on record the latest status/action taken regarding the FIR/DDR concerning the missing record.
7. Since the respondent has specifically stated that no response has been received from the **Commissioner of Police, Jalandhar** despite letter dated 24.10.2025 and reminder dated 14.09.2026, the **PIO/concerned officer of the Office of the Commissioner of Police, Jalandhar, shall be summoned to appear before the Commission on the next date of hearing** and explain the reasons for non-compliance/non-response to the communications issued by the respondent public authority.
