This order may be read in continuation of the previous order dated 11.06.2026 passed by the Commission.

2. Today the appellant submits that the requisite information has still not been received by him and that he is not satisfied with the information/point-wise reply furnished by the respondent.

3. The respondent submits that Sh. Nirmal Singh, XEN-cum-PIO, could not appear personally before the Commission today as he is stated to be busy in Election duty. The respondent further submits that the point-wise reply/information has already been furnished to the appellant.

4. In compliance with the directions issued by the Commission on the previous date of hearing, the respondent has brought an affidavit along with him. However, on perusal, the affidavit is found to be not duly notarised/attested by a Notary Public. Accordingly, the said affidavit is returned to the respondent with a direction to get the same duly notarised and submit it before the Commission on the next date of hearing.

5. It is pertinent to note that, vide the earlier order dated 11.06.2026, Sh. Nirmal Singh, XEN-cum-PIO, was specifically directed to remain personally present before the Commission and to furnish a comprehensive point-wise reply duly supported by an affidavit, alongwith a written explanation in response to the show cause notice already issued to him.

6. Despite the specific directions of the Commission, the concerned officer has not appeared personally today and the affidavit produced is not duly notarised. Further, the appellant continues to submit that the requisite information has not been received by him

7. The repeated non-compliance with the specific directions of the Commission, and failure to furnish the affidavit in the manner directed, reflects a lack of due seriousness towards the statutory proceedings under the Right to Information Act, 2005. The matter, therefore, requires consideration at an appropriate higher level.
