ORDER

The RTI application is dated 22.10.2025 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 29.10.2025 and second appeal was filed in the Commission on 05.12.2025 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing on 27.08.2026 but was postponed due to administrative reasons. Accordingly, the case was fixed for hearing today i.e. 15.09.2026.

2. The appellant sought the following information:

Subject: Request for information regarding access of my Call Detail Records (CDRs).
Sir/Madam,
I wish to seek information under the Right to Information Act, 2005 regarding any access or requisition made by the District Police, Mohali, for my Call Detail Records.
Please provide the following details:
Whether any requisition or request was made to any telecom service provider for my mobile number 84106-00001 during the period 01 July 2024 to 18 July 2024.

The date, purpose, and authority under which such access was made, if any.

Copy of the approval or authorisation issued by the competent authority, if available.

If no such access was made, kindly confirm the same in writing.

3. The appellant filed above said application to the Public Information Officer but due to non-satisfaction, he filed the First Appeal before the First Appellate Authority. Feeling aggrieved, he filed the second appeal.

4. Thereafter, the appellant filed the CWP No. 25498 of 2026, which was decided by the Hon'ble Punjab and Haryana High Court on 13.08.2026, the relevant portion of the said order is as follows:

1. The present writ petition has been filed under Articles 226/227 of the Constitution of India seeking direction upon respondent No.1 to decide and pass an order in second appeal bearing Application No.222035 dated 26.11.2025 (Annexure P-5) filed by the petitioner under Section 19(3) of Right to Information Act, 2005, in a time bound manner.

2. Learned counsel for the petitioner submits that the petitioner filed an application dated 22.10.2025 seeking certain information from respondent No.3 with regard to requisition for his 'Call Detail Records', which was dismissed. Even the first appeal filed thereagainst stands dismissed. It is submitted that the petitioner has now preferred second appeal, which is pending adjudication before respondent No.1. The petitioner will be satisfied, at this stage, in case a direction is issued to the respondents concerned, to decide the same by passing an appropriate speaking order in a time bound manner.
