In response to this advertisement, 41 applications were received. Thereafter, in November 2023, Government ordered an extension of 15 days in submission of applications and accordingly an advertisement was published in Hindustan Times, The Tribune, Punjabi Tribune and Dainik Bhaskar on 01.12.2023 for the position. The last date for receipt of applications was 15.12.2023. In response to this advertisement, 26 applications have been received. Therefore, total applications received are 67.

The Search Committee considered all the 67 applications received within the stipulated timeline for the position of Chief Information Commissioner, Punjab. The Committee deliberated upon the comparative merits of all the applicants and their educational qualifications and considered their experience and contribution to public life. In response to the advertisement, 136 applications for SIC were received. Thereafter, in November 2023, the period was extended by another 15 days to allow more candidates to apply. In response to this advertisement, 68 more applications have been received. Therefore, total applications received for SIC are 204.
 - 3.0 The Committee considered and examined all the applications received within the stipulated timeline for the three vacant positions of State Information Commissioners, Punjab. The Committee deliberated upon the comparative merits of all the applicants based on the knowledge and experience on various issues as mentioned in see 15(5) of the RTI Act. The Search Committee felt that people of eminence who have
